What is the purpose of this update?

This document tells you how the SIL Employer Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Superannuation Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

The current management agreement between the trustee and ANZ Investments expires on 1 January 2026. The trustee and ANZ Investments do not intend to renew this agreement, although it may be extended for a short period if necessary to facilitate an orderly transition to a new manager. The trustee is in the process of appointing a new manager to undertake the investment management and administration services following the expiry of the existing management agreement.

Description of this fund


The SIL Employer Conservative Fund invests mainly in income assets (cash and cash equivalents and fixed interest), with a smaller exposure to growth assets (equities, listed property and listed infrastructure). The fund may also invest in alternative assets.

The SIL Employer Conservative Fund aims to achieve a return (after the fund charge and before tax) on average over rolling three-year periods that outperforms the composite index.

What are the risks of investing?

Risk indicator for the SIL Employer Conservative Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

*During the next scheme year, other management and administration charges will include an estimated one-off cost of up to 0.09% to transition the investment management and administration services to a new manager. This cost will be partially offset by a reduction in the manager's basic fee from 0.79% to 0.76% effective 1 August 2025.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds).

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$478 (that is 4.78% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$478 for the year.

Actual investment mix²


